Chapter 6

Warranties, Forms, and
Applications

6.1 GENERAL WARRANTY INFORMATION

Malarkey offers several types of warranties covering our products, and they are described below.

Malarkey warranties are subject to the terms and conditions set forth in each. Refer to the sample warranties in this chapter for specifics applicable to each.

6.1.1 LIMITED MATERIAL-ONLY WARRANTIES

All Malarkey shingle, steep slope accessory, and roll products are subject to the terms and conditions of standard Malarkey limited warranties, cover only manufacturing defects that cause leaks¹, exclude consequential damages, and are subject to a declining prorated liability for the warranty period once an initial, non-prorated period has expired. Warranties in this category are mostly for individual homeowners but a couple can also include commercial building owners:

Standard Shingle & Accessory Warranty:

- Our basic residential homeowner warranty; all but two shingles offer Limited Lifetime coverage.
- Includes standard coverage against high winds and ways to acquire enhanced wind coverage.
- Several shingle types offer protection against damage caused by algae.
- There is also an option to choose a competitor's warranty terms over ours for "like" products, *Your Choice*.

SecureStart™ HT Limited Lifetime Warranty:

High-temperature underlayment with lifetime coverage when part of a complete roofing system.

Concrete and Clay Tile Underlayment Warranty:

Offers coverage for a wide selection of underlayment options and roof slope requirements.

10-Year Limited Warranty: For individual products, both steep and low slope applications.

Limited Systems Warranty: Varied durations of coverage depending on choice of low slope roofing systems.

When multiple Malarkey products are used in a greater roofing system, warranty terms are enhanced and can be shared to cover each component. Installation must follow all applicable building code requirements, established industry standards, and Malarkey's or the primary roofing manufacturer's published installation instructions.

6.1.2 ROOFING SYSTEM WARRANTIES THROUGH MALARKEY-VETTED AND APPROVED CONTRACTORS

Malarkey offers special warranties through roofing contractors who have gained Malarkey affiliation through a rigorous approval process, proved they can apply roofs in a conscientious manner, and utilize only Malarkey roofing products for their projects. We have two such programs:

- Certified Residential Contractors
- Commercial Approved Applicators

6.2 MALARKEY CERTIFIED RESIDENTIAL CONTRACTORS

The mission of the *Certified Residential Contractor* (CRC) Program is a shared value focus, bringing together homeowners needing a new roof with local, factory trained installers using quality Malarkey roofing products. An eligible *Secure Choice™ Roofing System* (SCRS) consists entirely of Malarkey shingles and accessory products.

The CRC Program offers numerous advantages: providing confidence to the homeowner that the contractor is trained, experienced, and knowledgeable; uses only the best roofing materials; and has distinguished themselves by the quality of their work.

Malarkey supports the CRC in this role with multiple tools: training, an online Program Guide (w/installation instructions), co-branded marketing materials, a finance program, and exclusive *Emerald Warranties* (see sample warranties later in this chapter).

A roofing contractor must qualify to become a CRC, and there are two levels, *Emerald Pro* and *Emerald Premium*.

6.2.1 EMERALD PRO CONTRACTOR

- Nominated and vetted by a Malarkey sales rep.
- Licensed, bonded, and insured (\$1 million)
- At least three (3) years in business
- In good standing with the Better Business Bureau (BBB) and state Construction Contractors Board, Association, etc.
- Conformance to local building codes and regulations
- Established safety program conforming to OSHA standards
- Completion of Malarkey's *Steep Slope Roofing Excellence* training

¹ The Emerald Premium Warranty also covers workmanship. See the warranty terms later in this chapter.

- Passed Malarkey's Steep Slope application test

Contractors at this level can offer exclusive, material-only **Emerald Pro Warranties**. An eligible SCRS consists of Malarkey shingles, three (3) or more Malarkey accessory products, and includes coverage for low slope roofs when part of the greater roofing system. Enhanced wind warranty coverage is standard.

6.2.2 EMERALD PREMIUM CONTRACTOR

- Nominated by Malarkey sales rep.
- Licensed, bonded, and insured (\$1 million)
- At least five (5) years in business
- Must have 90% or an "A" BBB customer satisfaction rating
- Three (3) references for work completed in last year for inspection
- Conformance to local building codes and regulations
- Established safety program conforming to OSHA standards
- Participant in the CRC Program at least one year prior to nomination for Premium level

Contractors at this level can offer exclusive **Emerald Premium Warranties**, which offer customers a combination of material warranty, *workmanship* warranty, and even coverage for low slope roofs when part of the greater roofing system. An eligible SCRS consists entirely of Malarkey shingles and accessory products. Enhanced wind warranty coverage is standard.

Once in the program, contractors will be issued login information to access the exclusive CRC Portal.

6.2.3 EMERALD PREMIUM PROJECTS 200 SQUARES OR MORE

Given their size, Emerald Premium warranted projects of 200 squares or more are applied-for differently from projects less than 200 squares. The process for successfully receiving an Emerald Premium Warranty for projects of this size are as follows:

1. Using the link in the CRC portal online, submit a completed *Emerald Premium Steep Slope Warranty Application* two (2) weeks prior to the start of the project, with plans, specs and details.

Warranty applications can also be obtained from your area Malarkey sales rep or by contacting our Technical Services Department.

2. Malarkey Technical Services will review the application and contact the contractor as needed.
3. Once reviewed and pre-approval granted, Tech Services will notify the contractor.
4. An initial inspection is required at the beginning of a project. A Malarkey inspector will contact the Emerald Premium contractor to coordinate the inspection.
5. Additional inspections may be required during the project and once the project is completed.
6. With the project finished, final inspections conducted and approved, and the remaining warranty fee paid, the warranty will be issued to the Emerald Premium contractor.

Other Considerations

- *Failure to submit an application prior to job start may result in additional warranty fees or non-issuance of a warranty.*
- Contractors are required to pay 50% of the warranty registration fee at the time of initial warranty application. The remaining amount is due at the time of warranty issuance.

6.3 MALARKEY COMMERCIAL APPROVED APPLICATORS

Malarkey *Commercial Approved Applicators* (CAA) must go through a number of qualifying steps in order to earn the designation:

- A background check that covers the roofer's business practices
- Inspection of Malarkey roofing system installations, both in progress and completed
- Knowledge their roofing crews are trained and understand Malarkey specifications and the information contained in this manual

Malarkey's Technical Services and Sales Departments make every effort to keep roofing crews up to date with the latest revisions to the Malarkey Product Data Guide, Specification Manual, individual installation instructions, and new products being developed.

6.3.1 NO DOLLAR LIMIT WARRANTIES

Commercial Approved Applicators can offer *No Dollar Limit* (NDL) roofing system warranties for both low and steep slope roofing systems. NDL warranties cover materials and workmanship with no dollar limit but have specific contractor, material, and installation requirements that must be followed.

Upon issuance of the warranty, Malarkey also includes our standard *Maintenance & Repair Guidelines* which outline procedures for:

- Periodic inspections and inspection practices
- What to look for: Areas prone to deterioration
- Reporting roof issues
- Roof repair (the CAA who installed the roof is responsible to undertake remedial repairs for a 2-yr. period)
- Building alterations and modifications

6.3.2 WARRANTY CHARGES

Contact Malarkey's Technical Services Department or local sales representative for current NDL warranty charges which may include:

- Administration fees needed to process the warranty
- Roofing project inspection fees (if inspections required)
- Travel expenses needed to conduct these inspections

6.3.3 THE WARRANTY PROCESS

Two weeks prior to project start date, the Malarkey Commercial Approved Applicator fills out a warranty application form, including a detailed roof plan and specifications, and submits it via email to Malarkey's Technical Services Department. Failure to do so may result in additional warranty fees or rejection of the warranty application.

The information is carefully reviewed, approved, and entered into the Warranty Database.

The approved warranty application form is then emailed to the roofing contractor, along with the warranty fee invoice.

Upon receipt of *half* the warranty fee up front, Malarkey will give notice for the project to proceed. An interim inspection date may be required for a Malarkey Roofing representative to visit the job site. The inspector will evaluate the work in progress and address any aspect in need of correction.

Following notice of job completion, a final inspection is ordered and conducted.

Once items in need of correction are resolved in a manner acceptable to Malarkey's Technical Services Department and warranty fee paid, the warranty is printed, signed, and sent to the roofing contractor.

6.3.4 INSPECTIONS

Normally, Malarkey will order inspections only for roof installations in process of being granted an

NDL Warranty. Commercial Approved Applicators are responsible for scheduling inspections at the completion of the project and then again in two (2) years.

Malarkey reserves the right to waive inspection(s) on a warranted roof when, in Malarkey's opinion, an inspection is not necessary or the location too remote from our company location or representatives. In such cases, the owner or designer can request a special inspection for which an additional charge may be made.


The purpose of an inspection conducted by Malarkey representatives is to gather information, address the present condition of the roofing system, and determine whether or not the installation is still eligible for the warranty.

Registration of the warranty is not required to receive full stated coverage of the warranty for your product, but is recommended.

The owner should retain a copy of the final invoice or contract as proof of purchase of installation.

All of our shingles come with a product warranty [see Table 1 on the next page for a complete listing], as well as the optional Accessory Products used as part of the roof system installation. Malarkey Accessory Products include:

- **Right Start® UDL** and **Secure Start®** line of synthetic field underlayments
- **Arctic Seal®** and **Secure Start® HT** self-adhering underlayments
- **Smart Start®** starter shingles
- **Malarkey Hip and Ridge Shingles** [EZ-Ridge® and RidgeFlex™]¹

Malarkey Roofing Products® warranties stand with any in the industry. Highlights of our coverage include:

- **A Right Start™ Period:** Every Malarkey warranty begins with a multi-year, non-prorated warranty period designed to protect your shingle investment and get it off to a good start. During this initial period shingles do not depreciate, and you enjoy 100% warranty coverage.
- **Transferability:** A warranty transfer is allowed within 60 days of the change in ownership of the house [see TRANSFERABILITY section].
- **Enhanced Wind Warranty Option:** Every Malarkey warranty includes protection against high winds and increases when you install a roofing system of Malarkey shingles and accessory products.
- **Scotchgard™ Protector:** Malarkey shingles that feature Scotchgard™ Protector from 3M™ also enjoy Limited Lifetime Warranty coverage against discoloration or staining due to blue-green algae growth.
- **Your Choice Warranty Option:** If you prefer another manufacturer's limited warranty to Malarkey's limited warranty for a similar product, we will honor their terms and conditions.

LIMITED LIFETIME WARRANTY

Most Malarkey shingles come with a Limited Lifetime Warranty against manufacturing defects that adversely affect the performance of the shingle. It is offered to individual homeowners who first had the shingles installed on the single family, detached house they use as their primary residence. "Lifetime" coverage is in effect as long as you, the original owner or eligible subsequent owner [following a successful warranty transfer], maintain as their primary residence, the house where the Malarkey shingles and accessories were installed.

When Malarkey Limited Lifetime Warrantied shingles are installed with two or more of the Malarkey Accessory Products listed above, those accessory items are also covered by the Limited Lifetime Warranty. Windsor® Starter shingles are not an accessory because they are required in Windsor® shingle installations and therefore covered by the Windsor® shingle warranty.

Other types of properties excluded from Lifetime coverage include houses no longer maintained by the original property owner or eligible subsequent owner as their primary residence, churches, schools, apartment buildings, condominiums, cooperative housing arrangements or buildings owned by corporations, trusts or government entities. These types of dwellings are limited to the warranty period listed in **Table 1 under TERM [NOT PRIMARY RESIDENCE]**.

RIGHT START™ PERIOD

Malarkey roofing products are manufactured to very high standards, and because of this, every shingle listed in Table 1 starts with an initial, *non-prorated Right Start™ Period* of 7 to 20 years, depending on the product, that states:

If the shingles are found to have manufacturing defects that adversely affect the performance of the shingle, Malarkey will either repair, replace or pay for installation of new shingles plus a reasonable cost for underlayment and other materials.

No payment will be made for tear-off or disposal of old roofing. Malarkey's maximum liability under this warranty shall be equal to the dollar limit [*per square** of material] expressed in Table 1, plus reasonable installation costs as defined by RS Means^{®2}. Given the situation, Malarkey retains the right to fulfill its obligation by providing replacement materials only. Malarkey will not be responsible for the cost of removal and replacement of any rooftop appurtenances or equipment installations in order to conduct repairs for valid claims, such as, but not limited to, solar panels.

* Square is a roofing term for the amount of material it takes to cover a 10-ft. by 10-ft. area of roof.

¹ Some contractors adapt 3-tab shingles to use as hip and ridge shingles. Dura-Seal® AR 3-tab shingles are allowed as hip and ridge shingles but only when the field shingles are also Dura-Seal® AR.

COVERAGE BEYOND THE RIGHT START™ PERIOD

Once the Right Start™ Period has passed, shingle values for the purpose of replacement are now prorated, decreasing each month by a certain percentage based on the number of months in their warranty, or term. For example, the Vista® shingle has a term of 40 years. Multiple that by the number of months in a year [12], and you get 480 months. Vista’s depreciation rate, expressed in the column, REDUCTION PER MONTH [see Table 1], is therefore, 1/480.

Another way to think about it is the dollar limit per square of shingles, reduced by the number of months the shingles have been on the roof.

Example 1: A claim for 40 squares of Vista® shingles that was settled 12 years after installation –

- A = number of affected squares: 40
- B = initial dollar limit/SQ: \$80
- C = the number of months that remain on the warranty: 480 [length of the term x 12 months/yr.] minus 144 [12 years shingles were on the roof x 12 months/yr.] = 336 months
- D = length of the term = 480 months
- **Prorated warranty value:** $[A \times B \times C] \div D = [40 \times 80 \times 336] \div 480 = \$2,240$

Any costs in excess of the prorated adjustment are the owner’s responsibility. If money was already paid under the warranty, the prorated warranty value will be reduced by that amount.

Limited Lifetime Warranty shingles, however, stop depreciating when they reach 80% of their term. Back to our example of the Vista® – its term is 40 years, or 480 months. 80% of 480 months is 384 months; therefore, the Vista® stops depreciating after 32 years $[384 \div 12 = 32]$.

ACCESSORY WARRANTIES (FOUR VARIATIONS)

1. When you install two or more Malarkey Accessory Products [listed on page 1] with any brand of Malarkey Limited Lifetime Warranty shingles, those accessory products carry the same Limited Lifetime Warranty along with its Right Start™ Period.
2. When you install one Malarkey Accessory Product with any brand of Malarkey Limited Lifetime Warranty shingles, that accessory product carries a 20-year warranty against manufacturing defects and a Right Start™ Protection Period of 5 years.
3. When you install one or more Malarkey Accessory Products with any Malarkey Non-Limited Lifetime Warranty shingle [i.e., Dura-Seal® AR], those accessory products carry a 10-year warranty against manufacturing defects and a Right Start™ Protection Period of 5 years.
4. Installed separately [for example, as part of a competitor’s roof system], every Malarkey Accessory Product carries a 10-year warranty against manufacturing defects.

LIMITED WIND WARRANTY & ENHANCED WIND WARRANTY

Malarkey shingle warranties include two types of wind warranties: a **Limited Wind Warranty** and an **Enhanced Wind Warranty**, and both protect against damage to shingles from high winds [i.e., shingle blow-off] for a period of 15 years.

Terms and Conditions: Malarkey’s wind warranties apply only when shingles are properly adhered, whether by hand-sealing with asphalt roof cement conforming to ASTM D4586 or by activation of the shingles’ self-sealing strips.

The Limited Lifetime Warranty covers Malarkey shingles up to the wind speeds in **Table 1, column Wind**.

The Enhanced Wind Warranty covers Malarkey shingles up to the wind speeds in **Table 1, column Enhanced Wind**.

In addition to the Limited Lifetime Warranty conditions, Enhanced Wind Warranty roof systems must also include application of Malarkey Smart Start® starter shingles, and either of Malarkey's Hip and Ridge shingles [EZ-Ridge® or RidgeFlex®]³.

Malarkey's maximum liability under wind warranties is, at its option, to repair or replace blown-off shingles [including materials and labor], hand-seal [or have hand-sealed] the shingles at our expense, or pay the owner an amount not exceeding the dollar limits expressed in Table 1, plus reasonable installation costs as defined by RS Means®. No amount shall be paid for removal or disposal of damaged shingles.

LIMITED ALGAE RESISTANT ROOFING SYSTEM WARRANTIES

Malarkey offers two shingle warranties against damage due to discoloration caused by the development of blue-green algae [primarily the cyanobacteria *Gloeocapsa spp*], and both require Malarkey algae resistant hip and ridge shingles⁴ [EZ-Ridge® or RidgeFlex®] featuring Scotchgard™ Protector from 3M™⁵.

The first warranty shares the same Limited Lifetime Warranty coverage offered on those Malarkey field shingles that feature Scotchgard™ Protector from 3M, subject to the conditions and limitations listed below.

The payment to the owner for those shingles that exhibit discoloration due to blue-green algae will be an amount not exceeding the dollar limits expressed in Table 1 and reasonable installation costs for your area as defined by RS Means®. Malarkey's maximum liability under this warranty is, at its option, to repair or replace the defective shingles or pay the owner an amount not exceeding the dollar limits expressed in Table 1 and reasonable installation costs as defined by RS Means®.

The second warranty covers Malarkey's Algae Resistant [AR] shingles.

These shingles are listed in Table 1 in the first column, and have "AR" after their name. These shingles are warranted against discoloration or staining due to blue-green algae growth, with a prorated settlement after five [5] years [60 months]. AR shingles and terms include:

SHINGLE	ALGAE WARRANTY TERM
Vista® AR	15 years
Highlander® AR	10 years
Dura-Seal® AR	5 years

For claims within the first five years meeting all warranty requirements, the payment to the owner for those shingles that exhibit discoloration due to blue-green algae will be an amount not exceeding the dollar limits expressed in Table 1 and reasonable installation costs for your area as defined by RS Means®.

³ Dura-Seal® AR shingles used for hip and ridge will qualify for Enhanced Wind Warranty coverage but only when Dura-Seal® AR is also the field shingle.

⁴ Dura-Seal® AR shingles used for hip and ridge will satisfy the requirements of algae resistance coverage but only when Dura-Seal® AR is also the field shingle.

After the first five [5] years [60 months], the settlement is prorated, and Malarkey may, at its discretion, repair, replace or offer a labor payment to cover the reasonable cost for cleaning the affected shingles. The maximum payment under this warranty will be prorated based upon the number of months the shingles have been installed on the roof up to the maximum warranty period. After the warranty period expires, there is no remedy for algae on AR shingles.

Malarkey's maximum liability for blue-green algae is, at its option, to repair or replace the defective shingles or pay the owner an amount not exceeding the dollar limits expressed in Table 1 and reasonable installation costs as defined by RS Means® [prorated after 60 months].

TRANSFERABILITY

During the Right Start™ Period, these warranties may be transferred, but only by the original property owner to the first subsequent owner, after notification to Malarkey as described below. If the transfer takes place within the Right Start™ Period, the eligible new owner is entitled to the balance of the original warranty and Right Start™ period. "Lifetime" warranty coverage is transferable as long as the subsequent owner maintains the home as their primary residence. If the transfer occurs after the Right Start™ Period, the warranty to the subsequent owner will be limited to two [2] years from the date of the real estate title transfer. Warranty coverage will be as stated in the COVERAGE BEYOND THE RIGHT START™ PERIOD section.

To transfer the warranty, the current holder of the warranty must notify Malarkey's Warranty Services Department [see the CLAIMS PROCEDURE section] in writing within sixty [60] days from the date the title of the property was changed. We will either send you a *Shingle Warranty Transfer* document to fill out or simply request you provide us with the following information:

- The name, address and phone of the current holder of the warranty
- The date of the original, completed installation
- Proof of purchase
- The address where the shingles were installed
- The name and address of the new owner, and
- The date of title transfer

If Malarkey is not notified of the transfer as outlined above, the warranty shall not transfer, and Malarkey will have no further liability of any nature to the warranty holder.

EXCLUSIONS

The Limited Lifetime Warranty covers only manufacturing defects in Malarkey shingles that adversely affect the performance of the shingle. It covers the asphalt shingle products listed in Table 1 that are sold and installed in the U.S. and Canada. Warranty claims that Malarkey determines are cosmetic in nature are not considered manufacturing defects. The warranty does not cover other products such as flashing and metal work or damage to shingles attributable in whole or in part to other causes including, but not limited to:

- Improper fastening or installation not in accordance with Malarkey's written instructions
- Improper ventilation
- Improper transportation, storage, or handling of shingles and/or accessories
- Defects in, or failure of, flashing or metal work or material used as a roof face over which shingles are applied

- Penetrations of the roofing system for installation of rooftop appurtenances (solar panels, satellite dishes, stovepipes, etc.), structural changes, or other alterations to the roof after application of the shingles
- Inordinate traffic on the roof for any reason (equipment installation/ removal, moss and debris removal, gutter cleaning, etc.)
- Settlement, movement, distortion, failure or cracking of the roof decks, walls or foundations of the building
- Damage to shingles, roof deck, or structure due to ice damming or water backup
- Variation in color (shading) which may occur from the positioning of colored granules on the shingles. Shading or discoloration of shingles or ridges due to algae (excluding AR or Scotchgard™ shingles as described in the Limited Algae Resistant Roofing System Warranties section)
- Deterioration or distortion caused by moss, mold, mildew, or other vegetation, organic compounds, paints, chemicals, or similar materials
- Granule sloughing due to excessive granules on the shingles
- Impact of foreign objects
- Violent or unusual weather conditions, such as flooding, tornadoes, hailstorms, winds in excess of Wind Speed Limits (Table 1), or other "Acts of God"

Color Match. 





An eligible *Secure Choice™ Roofing System* (SCRS) consists of Malarkey shingles [see Table 1 for a complete list] and three (3) or more Malarkey accessory products, and shall be installed by a Malarkey *Emerald Pro Certified Residential Contractor* (CRC) using our latest published installation instructions and adopted building code requirements.

THE EMERALD PRO WARRANTY: WHO AND WHAT IS COVERED

Two distinct types of *housing* are covered under the Warranty:

Single Family, Detached Residences

- A Malarkey SCRS approved for the Warranty comes with a LIMITED LIFETIME WARRANTY against *manufacturing defects* that adversely affect performance of the roofing system. It is offered to individual homeowners who first had the shingles installed on the single family, detached house they use as their primary residence. "Lifetime" coverage remains in effect as long as the original owner or eligible subsequent owner *maintains as their primary residence*, the house where the Malarkey SCRS was installed.

Other Structures

- Other types of structures excluded from Lifetime coverage include houses no longer maintained by the owner(s) as their primary residence, duplexes, townhouses, apartment buildings, condominiums, and professional buildings, such as churches, hospitals, and schools. These structures are covered against manufacturing defects for twenty to fifty (20 to 50) years based on the product listed in Table 1.

Note: A *one-time* transfer of the warranty to a second owner is allowed under the program [e.g., following the sale of the house or building]. See the *TRANSFERABILITY* section for more information.

RIGHT START™ PERIOD

Malarkey roofing products are manufactured to very high standards, and because of this, every shingle's warranty period [see Table 1 below] includes a non-prorated Right Start™ Period that states:

If any component of the SCRS is found to have manufacturing defects that materially affect performance of the system, Malarkey will either repair, replace, or pay for installation of replacement materials as necessary. The costs for tear-off and disposal of some or all of the Malarkey roofing products are included if necessary to repair your roof.

Malarkey will not be responsible for the cost of removal and replacement of any rooftop appurtenances or equipment installations in order to conduct repairs for valid claims such as, but not limited to, solar panels.

Malarkey Roofing Products® and related warranties stand with any in the industry. The warranty coverage includes:

- **A Right Start™ Period:** Every Malarkey warranty includes a multi-year, non-prorated warranty period designed to protect your shingle investment for years to come. During this period shingles do not depreciate, and you enjoy 100% warranty coverage.

Coverage Beyond the Right Start™ Period: Once the Right Start™ Period has passed for *Single Family* structures, if any component of the SCRS is found to have manufacturing defects that materially affect performance of the system, the repair or replacement value of those components are prorated and retain 20% of their original value.

The Right Start™ Period for *Other Structures*¹ is split with the first twenty (20) years being non-prorated and the remainder of the warranty period, prorated. The prorated value is determined by a certain percentage based on the remaining number of months in their warranty (see Table 1, last column).

Any costs in excess of the prorated adjustment are the owner's responsibility. If money was already paid under the warranty, the prorated warranty value will be reduced by that amount.

SYSTEM REQUIREMENTS

The Emerald Pro Warranty requires Malarkey shingles as well as three (3) or more Malarkey accessory products, including underlayment, starter shingles, and hip and ridge shingles. These qualified, accessory products include:

WIND DAMAGE COVERAGE

Malarkey SCRS's completed by Emerald Pro Certified Residential Contractors are covered against loss from wind damage for 15 years.

Note: Malarkey's wind warranties apply only when shingles are properly adhered, whether by hand-sealing with asphalt roof cement conforming to ASTM D4586 or by activation of the shingles' self-sealing strips. Malarkey's maximum liability under wind warranties is, at its option, to either repair or replace blown-off shingles (including materials and labor) or be allowed the opportunity to hand-seal (or have hand-sealed) the shingles at our expense.

ALGAE RESISTANCE COVERAGE

The Emerald Pro Warranty offers **two levels of coverage against damage due to discoloration caused by the development of blue-green algae** (primarily the cyanobacteria *Gloeocapsa* spp):

For roofs that include low slope, Malarkey OmniSeal® Roof Systems, up to 10 squares qualify for limited warranty coverage. Specific systems include:

Warranty coverage begins from the date installation of the membranes is complete and includes any manufacturing defects discovered during the warranty coverage period(s) listed in the table above. The maximum liability will be for materials to replace the covered low slope roof system with the same or similar materials.

Rooftop components that are not part of the low slope membrane application, even if installed at the same time, are not covered by this limited warranty. Such components include but are not limited to:

- The underlying roof deck
- Insulation and related fasteners
- Vapor retarders/barriers and related fasteners
- Assorted metal work: flashing, drains, pitch pans, vents, expansion joints, etc.
- Plastic accessories
- Penetrations like skylights and hatches
- Solar photovoltaic panels
- Roof coatings
- Surfacing, ballast of aggregates/gravel

TRANSFERABILITY

The Emerald Pro Warranty can be transferred *once* during the life of the warranty. Malarkey must be notified in writing and a warranty transfer application *completed within sixty (60) days* of real estate transfer or warranty becomes void. Transfer information shall include:

- The name, address, and phone of the original holder of the warranty
- The address where the shingles were installed
- The date of the original, completed installation
- The name, address, and phone of the Malarkey Emerald Pro Certified Contractor
- Proof of purchase
- The name and address of the new owner
- The date of title transfer

² Scotchgard, the Scotchgard logo and 3M are trademarks of the 3M Company.
³ Some contractors adapt 3-tab shingles to use as hip and ridge shingles. The use of Dura-Seal® AR for this purpose will satisfy the requirements of algae resistance coverage but only when Dura-Seal® AR is also the field shingle.

If the transfer takes place within the Right Start™ Period, the eligible new owner is entitled to the balance of the original warranty and Right Start™ Period. Lifetime warranty coverage is transferable as long as the subsequent owner maintains the home as their primary residence.

If the transfer occurs *after* the Right Start™ Period expires, the balance of the warranty is reduced to the earlier of: [1] a five (5) year period after the date of ownership change; or [2] the expiration of the Limited Lifetime Warranty. Should there be a discoverable manufacturing defect during this five (5) year period, our obligation to the eligible new owner will be based on the reasonable cost of roofing system replacement, prorated by the duration of use from the original installation date through the date of the claim.

REQUIRED COMPONENTS, PROCEDURES, AND STANDARDS

1. Malarkey Roofing Products® shingles and Malarkey accessory products must be installed on the structure to be eligible for the Emerald Pro Warranty.
2. All work must be completed by a Malarkey Emerald Pro or Premium Certified Residential Contractor and installed according to Malarkey's latest published installation instructions and adopted building code.
3. The building structure and roof deck must be sound, comply with all local codes and ordinances, and sufficient to support the weight of the roofing system and transient load during application.
4. The roof deck must be an acceptable substrate:
 - a. Sheathing panels shall meet adopted building code requirements and be at least 3/8" [10 mm] thick, exterior-grade plywood or 7/16" [11 mm] oriented strand board (OSB).
Malarkey strongly recommends installing sheathing when wood board decking is the existing substrate and required when boards are greater than 6" [152 mm] wide. Problems with the performance of your roofing system, such as leaks and buckling, increase if installed directly over wood board decks. Failure to use properly conditioned deck materials can result in deck movement, which can damage the roof covering and may void your warranty.
 - b. Likewise, sheathing panels should be supported, gapped and securely nailed to all framing members per APA recommendations.
 - c. **Installing over existing roofing materials (i.e., re-covering) or deteriorated wood products is not acceptable. A complete tear-off is required.**
5. Besides replacement of warped or rotted decking, repairs are required at other areas of roof that could lead to leaks unrelated to proper installation of the Malarkey roofing system such as deteriorated chimney mortar joints, etc.

6. Smart Start® starter shingles to be applied to both eave and rake edges of the roof.
7. Coverage will not take effect until all payments relative to this warranty have been paid in full to Malarkey, the CRC, and material supplier, including costs for warranty registration, installation, supplies, etc.
8. Warranty registration requires proof of purchase.

EXCLUSIONS

The Emerald Pro Warranty covers only *manufacturing defects* in Malarkey shingles. It includes the Malarkey roofing shingles listed in Table 1 and related accessories sold and installed in the U.S. and Canada. Warranty claims that Malarkey determines are cosmetic in nature *are not* considered manufacturing defects. The warranty does not cover other products such as flashing and metal work or damage to shingles attributable in whole or in part to other causes including, but not limited to:

- Improper fastening or installation not in accordance with Malarkey's written instructions
- Improper ventilation
- Improper transportation, storage, or handling of shingles and/or accessories
- Installation by a contractor other than a Malarkey *Emerald Pro Certified Residential Contractor*
- Penetrations of the roofing system for installation of rooftop appurtenances (solar panels, satellite dishes, vent pipes, etc.), structural changes, or other alterations to the roof after application of Malarkey roofing products
- Inordinate traffic on the roof for any reason (equipment installation, moss and debris removal, gutter cleaning, etc.)
- Settlement, movement, distortion, failure or cracking of the roof decks, walls or foundations of the building
- Damage to shingles, roof deck, or structure due to ice damming or water backup
- Variation in color (shading) which may occur from the positioning of colored granules on the shingles
- Shading or discoloration of shingles or ridges due to algae [excluding Scotchgard™ or AR shingles as described in the *ALGAE RESISTANCE COVERAGE* section]
- Deterioration or distortion caused by moss, mold, mildew, or other vegetation, organic compounds, paints, chemicals, or similar materials
- Granule sloughing due to excessive granules on the shingles
- Impact of foreign objects
- Violent or unusual weather conditions, such as flooding, hurricanes, tornadoes, hailstorms, winds in excess of Wind Speed Limits [Table 1], or other extreme forces of nature
- Fire, acts of vandalism, and other, similar occurrences

Note: Malarkey continually strives to improve shingle durability and enhance our product line. In support of this, Malarkey reserves the right to discontinue or modify any of its products, including the color blend of shingles, without notice to the owner and shall not be liable to the owner as a result of this modification or discontinuance. If your shingles are no longer available, Malarkey reserves the right to provide you with substitute shingles comparable in quality, price, and color to your original shingles.

REGISTRATION

Warranties must be filed online by your Malarkey Certified Roofing Contractor. The warranty registration fee, which will be quoted by your contractor, is payable in US dollars. Malarkey is not responsible for any additional bank fees, taxes or transactions that have been implemented by your banking institution. Please contact your local customs office or banking institutions should you have any questions.

CANADA ONLY: If you would like to pay via business cheque, please mail your payment (business cheque) to the Malarkey Corporate office Attn: Warranty Services Department.

COMPENSATION

Malarkey may, at its sole discretion under this Emerald Pro Warranty, either: [1] issue a combination of cash and/or material credit to an existing supplier of Malarkey roofing materials; or [2] provide replacement materials only. The prorated material costs will be determined by time of use and the original cost of the SCRS at the time of original purchase.

CLAIMS PROCEDURE

1. Claims shall be made in writing by certified or registered mail within thirty [30] days of discovery and prior to any permanent repairs [except emergency measures to prevent potential damage to the building or its contents] being made. Include proof of purchase and proof of warranty.
2. Malarkey will be given the opportunity to inspect the roof and be provided with samples before any steps are taken to repair the roof.
3. After verification the roofing materials are defective, Malarkey will perform its obligations under this warranty within forty-five [45] days of receipt of notice, unless performance is delayed by causes beyond Malarkey's control. Any cost in excess of the prorated adjustment if loss is discovered after the Right Start™ Period will be the owner's responsibility.

SOLE AND EXCLUSIVE WARRANTY

THIS LIMITED WARRANTY IS THE ONLY EXPRESS AND/OR IMPLIED WARRANTY MADE BY MALARKEY IN CONNECTION WITH THE SALE OF ITS PRODUCTS. THE TERMS AND CONDITIONS CONTAINED HEREIN CONSTITUTE THE ENTIRETY OF YOUR LIMITED WARRANTY, REGARDLESS OF ANY FUTURE REVISIONS OF WARRANTY TERMS FOR LATER-INSTALLED SHINGLES.

NO REPRESENTATIVE OF MALARKEY OR ANY OTHER PERSON HAS ANY AUTHORITY WHATSOEVER TO ACCEPT FROM OR FOR MALARKEY, ANY ADDITIONAL OR DIFFERENT LIABILITY OR RESPONSIBILITY FOR MALARKEY PRODUCTS. NO SAMPLE WARRANTY AVAILABLE ON MALARKEY'S WEBSITE OR ELSEWHERE WHOSE TERMS AND CONDITIONS DIFFER FROM THOSE CONTAINED HEREIN WILL BE APPLICABLE TO YOUR SHINGLES.

MALARKEY SHALL NOT BE LIABLE FOR DAMAGE TO ANY BUILDING OR CONTENTS OR INJURY TO PERSONS OR FOR ANY CONSEQUENTIAL DAMAGES RESULTING FROM BREACH OF THE WARRANTY OR ANY OTHER WARRANTY OR CONDITION, IMPLIED BY LAW OR OTHERWISE, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS. SOME STATES AND PROVINCES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES; THIS EXCLUSION MAY NOT BE APPLICABLE IN ALL STATES AND PROVINCES. THIS WARRANTY GIVES SPECIFIC LEGAL RIGHTS; THERE MAY BE OTHER RIGHTS THAT VARY STATE TO STATE AND PROVINCE TO PROVINCE.

THE PARTIES AGREE THAT ANY CLAIM, DISPUTE, OR CONTROVERSY RELATING TO OR ARISING FROM THIS WARRANTY SHALL BE SUBMITTED TO BINDING ARBITRATION UNDER THE RULES OF THE AMERICAN ARBITRATION ASSOCIATION [OR OTHER MUTUALLY ACCEPTABLE ARBITRATOR] THEN IN EFFECT. The expenses of the arbitration shall be allocated among the parties by the arbitrator[s] as part of the award, which shall include the prevailing party's reasonable attorneys' fees and costs, including expert fees. THIS IS A BINDING ARBITRATION PROVISION THAT MAY BE ENFORCED BY THE PARTIES.

This warranty is enforceable only by the original owner named below or the eligible new owner who filed a timely warranty transfer request and received confirmation from Malarkey the transfer was accepted.

This Emerald Pro Warranty will not be valid until the Emerald Pro Certified Residential Contractor who installed the roof completes WARRANTY REGISTRATION online at www.malarkeyroofing.com, and the warranty has been accepted by Malarkey Roofing Products.

The owner and eligible new owner should retain all documents and proofs of purchase of Malarkey products for submission to Malarkey should a claim arise.



Thank you for choosing Malarkey Roofing Products® [Malarkey] shingles for your recent roofing project. Our **Emerald Premium Warranty** (the Warranty) is available exclusively through Malarkey's *Certified Residential Contractor Program* and offers customers an enhanced roofing system warranty that is a combination *material warranty* and *workmanship warranty*; you get quality Malarkey products and a warranted installation.

An eligible *Secure Choice™ Roofing System* (SCRS) consists entirely of Malarkey shingles (see Table 1 for a complete list) and Malarkey accessory products, and shall be installed by a Malarkey *Emerald Premium Certified Residential Contractor* (CRC) using our latest published installation instructions and adopted building code requirements.

Metal flashings and drip edge metal must also be installed. Step flashing is required at intersecting sidewalls, chimney applications, and other vertical transitions. Counter flashing is required per NRCA guidelines where applicable.

THE EMERALD PREMIUM WARRANTY: WHO & WHAT IS COVERED

Two distinct types of *housing* are covered under the Warranty:

Single Family, Detached Residences

- A Malarkey SCRS approved for the Warranty comes with a LIMITED LIFETIME WARRANTY against *manufacturing defects* that adversely affect the performance of the roofing system. It is offered to individual homeowners who first had the shingles installed on the single family, detached house they use as their primary residence.

"Lifetime" coverage remains in effect as long as the original owner or eligible subsequent owner *maintains as their primary residence*, the house where the Malarkey SCRS was installed.

Other Structures

- Other types of structures excluded from Lifetime coverage include houses no longer maintained by the owner(s) as their primary residence, duplexes, townhouses, apartment buildings, condominiums, and professional buildings, such as churches, hospitals, and schools. These structures are covered against manufacturing defects for twenty to fifty (20 to 50) years based on the product listed in Table 1.

Note: A *one-time* transfer of the warranty to a second owner is allowed under the program [e.g., following the sale of the house or building]. See the *TRANSFERABILITY* section for more information.

RIGHT START™ PERIOD

Malarkey roofing products are manufactured to very high standards, and because of this, every shingle's warranty period [see Table 1 below] includes a *non-prorated Right Start™* Period that states:

If any component of the SCRS is found to have manufacturing defects that materially affect performance of the system, Malarkey will either repair, replace or pay for installation of replacement materials as necessary. The costs for tear-off and disposal of some or all the Malarkey roofing products are included if necessary to repair your roof.

Malarkey will not be responsible for the cost of removal and replacement of any rooftop appurtenances or equipment installations in order to conduct repairs for valid claims such as, but not limited to, solar panels.

Malarkey Roofing Products® and related warranties stand with any in the industry. The warranty coverage includes:

- **A Right Start™ Period:** Every Malarkey warranty includes a multi-year, non-prorated warranty period designed to protect your shingle investment for years to come. During this period shingles do not depreciate, and you enjoy 100% warranty coverage.

Coverage Beyond the Right Start™ Period: Once the Right Start™ Period has passed for *Single Family* structures, if any component of the SCRS is found to have manufacturing defects that materially affect performance of the system, the repair or replacement value of those components are prorated and retain 20% of their original value.

The Right Start™ Period for *Other Structures*¹ is split with the first twenty (20) years being non-prorated and the remainder of the warranty *Term*, prorated. The prorated value is determined by a certain percentage based on the remaining number of months in their warranty (see Table 1, last column).

Any costs in excess of the prorated adjustment are the owner's responsibility. If money was already paid under the warranty, the prorated warranty value will be reduced by that amount.

CONTRACTOR WORKMANSHIP PERIOD

The Warranty also includes *workmanship coverage* for the period listed in Table 1. Workmanship includes any aspect of the installation found to adversely affect the performance of the SCRS or cause a leak. The Emerald Premium Certified Residential Contractor will warrant the initial five (5) years of installation liability, and Malarkey will cover the balance.

During the *Contractor Workmanship Period*, if any part of the Malarkey SCRS is found to have workmanship defects, Malarkey, at its sole discretion, will arrange to have the roof repaired or re-covered [flashings too, if necessary] and provide a reasonable cost for the labor required to accomplish adequate tear-off, disposal, and replacement.

¹ The Right Start™ Period for Other Structures with Dura-Seal® AR shingles is split with the first ten (10) years non-prorated and the remainder, prorated.

Malarkey retains the right to fulfill its obligation by providing replacement materials and compensation as defined below, for the reasonable cost of labor and other materials needed to repair or replace your roof, including tear-off and disposal costs.

SYSTEM REQUIREMENTS

The Emerald Premium warranty requires Malarkey shingles as well as Malarkey accessory products, including underlayment, starter shingles, and hip and ridge shingles. These qualified, accessory products include:

WIND DAMAGE COVERAGE

Malarkey SCRS's completed by Emerald Premium Certified Residential Contractors are also covered against loss from wind damage for 15 years.

Note: Malarkey's wind warranties apply only when shingles are properly adhered, whether by hand-sealing with asphalt roof cement conforming to ASTM D4586 or by activation of the shingles' self-sealing strips. Malarkey's maximum liability under wind warranties is, at its option, to either repair or replace blown-off shingles [including materials and labor] or be allowed the opportunity to hand-seal [or have hand-sealed] the shingles at our expense.

ALGAE RESISTANCE COVERAGE

The Emerald Premium Warranty offers two levels of coverage against damage due to discoloration caused by the development of blue-green algae [primarily the cyanobacteria *Gloeocapsa* spp]:

Warranty coverage begins from the date installation of the membranes is complete and includes any manufacturing defects discovered during the warranty coverage period(s) listed in the table above. The maximum liability will be for materials to replace the covered low slope roof system with the same or similar materials.

Rooftop components that are not part of the low slope membrane application, even if installed at the same time, are not covered by this limited warranty. Such components include but are not limited to:

- The underlying roof deck
- Insulation and related fasteners
- Vapor retarders/barriers and related fasteners
- Assorted metal work: flashing, drains, pitch pans, vents, expansion joints, etc.
- Plastic accessories
- Penetrations like skylights and hatches
- Solar photovoltaic panels
- Roof coatings
- Surfacing, ballast of aggregates/gravel

TRANSFERABILITY

The Emerald Premium Warranty can be transferred *once* during the life of the warranty. Malarkey must be notified in writing and a warranty transfer application *completed within sixty (60) days* of real estate transfer or warranty becomes void. Transfer information shall include:

- The name, address, and phone of the original holder of the warranty
- The address where the shingles were installed
- The date of the original, completed installation
- The name, address, and phone of the Malarkey Emerald Premium Certified Contractor
- Proof of purchase
- The name and address of the new owner
- The date of title transfer

If the transfer takes place within the Right Start™ Period, the eligible new owner is entitled to the balance of Right Start™ Period coverage plus the Contractor Workmanship coverage originally stated in the warranty. Lifetime warranty coverage is transferable as long as the subsequent owner maintains the home as their primary residence.

If the transfer occurs *after* the Right Start™ Period expires, the balance of the warranty is reduced to the earlier of: [1] a five [5] year period after the date of ownership change; or [2] the expiration of the Limited Lifetime Warranty. Should there be a discoverable manufacturing defect during this five [5] year period, our obligation to the eligible new owner will be based on the reasonable cost of roofing system replacement, prorated by the duration of use from the original installation date through the date of the claim.

REQUIRED COMPONENTS, PROCEDURES AND STANDARDS

1. Malarkey Roofing Products® shingles and Malarkey accessory products must be installed on the structure to be eligible for the Emerald Premium Warranty.
2. All work must be completed by a Malarkey *Emerald Premium Certified Residential Contractor* and installed according to Malarkey's latest published installation instructions and adopted building code.
3. The building structure and roof deck must be sound, comply with all local codes and ordinances, and sufficient to support the weight of the roofing system and transient load during application.
4. The roof deck must be an acceptable substrate:
 - a. Sheathing panels shall meet adopted building code requirements and be at least 3/8" [10 mm] thick, exterior-grade plywood or 7/16" [11 mm] oriented strand board [OSB].

Malarkey requires the installation of sheathing when wood board decking is the existing substrate. Problems with the performance of your roofing system, such as leaks and buckling, increase if installed directly over wood board decks. Failure to use properly conditioned deck materials can result in deck movement, which can damage the roof covering and may void your warranty.
 - b. Likewise, sheathing panels should be supported, gapped and securely nailed to all framing members per APA recommendations.
 - c. **Installing over existing roofing materials [i.e., re-covering] or deteriorated wood products is not acceptable. A complete tear-off is required.**
5. Besides replacement of warped or rotted decking, repairs are required at other areas of roof that could lead to leaks unrelated to proper installation of the Malarkey roofing system such as deteriorated chimney mortar joints, etc.

6. Application of Arctic Seal® self-adhering membrane is required around sheet metal accessory penetrations, flanges, and flashings.
7. Sheet metal flashing, edge metal, and accessories must be installed at roof intersections, vertical transitions to sidewalls, curbs, and chimneys, and around roof openings. *New/like* new flashings and accessories are required to match the projected life cycle of the roof.
8. Smart Start® starter shingles to be applied to both eave and rake edges of the roof.
9. Coverage will not take effect until all payments relative to this warranty have been paid in full to Malarkey, the CRC, and material supplier, including costs for warranty registration, installation, supplies, etc.
10. Warranty registration requires proof of purchase.

EXCLUSIONS

The Emerald Premium Warranty covers *defects in manufacturing and workmanship*. It includes the Malarkey roofing shingles listed in Table 1 and related accessories sold and installed in the U.S. and Canada. Warranty claims that Malarkey determines are cosmetic in nature are *not* considered manufacturing defects. The warranty does not cover other products such as flashing and metal work or damage to shingles attributable in whole or in part to other causes including, but not limited to:

- Improper ventilation
- Improper transportation, storage, or handling of shingles and/or accessories
- Installation by a contractor other than a *Malarkey Emerald Premium Certified Residential Contractor*
- Penetrations of the roofing system for installation of rooftop appurtenances [solar panels, satellite dishes, vent pipes, etc.], structural changes, or other alterations to the roof after application of Malarkey roofing products
- Inordinate traffic on the roof for any reason [equipment installation, moss and debris removal, gutter cleaning, etc.]
- Settlement, movement, distortion, failure or cracking of the roof decks, walls or foundations of the building
- Damage to shingles, roof deck, or structure due to ice damming or water backup
- Variation in color [shading] which may occur from the positioning of colored granules on the shingles
- Shading or discoloration of shingles or ridges due to algae [excluding AR or Scotchgard™ shingles as described in the *ALGAE RESISTANCE COVERAGE* section]
- Deterioration or distortion caused by moss, mold, mildew, or other vegetation, organic compounds, paints, chemicals, or similar materials
- Granule sloughing due to excessive granules on the shingles
- Impact of foreign objects
- Violent or unusual weather conditions, such as flooding, tornadoes, hailstorms, winds in excess of Wind Speed Limits [Table 1], or other extreme forces of nature
- Fire, acts of vandalism, and other, similar occurrences.

Note: Malarkey continually strives to improve shingle durability and enhance our product line. In support of this, Malarkey reserves the right to discontinue or modify any of its products, including the color

blend of shingles, without notice to the owner and shall not be liable to the owner as a result of this modification or discontinuance. If your shingles are no longer available, Malarkey reserves the right to provide you with substitute shingles comparable in quality, price and color to your original shingles.

REGISTRATION

Warranties must be filed online by your Malarkey Certified Roofing Contractor. The warranty registration fee, which will be quoted by your contractor, is payable in US dollars. Malarkey is not responsible for any additional bank fees, taxes or transactions that have been implemented by your banking institution. Please contact your local customs office or banking institutions should you have any questions.

CANADA ONLY: If you would like to pay via business cheque, please mail your payment (business cheque) to the Malarkey Corporate office Attn: Warranty Services Department.

COMPENSATION

Malarkey may, at its sole discretion under this Emerald Premium Warranty, either: [1] issue a combination of cash and/or material credit to an existing supplier of Malarkey roofing materials; or [2] provide replacement materials only. The prorated material costs will be determined by time of use and the original cost of the SCRS at the time of original purchase.

CLAIMS PROCEDURE

1. Claims shall be made in writing by certified or registered mail within thirty (30) days of discovery and prior to any permanent repairs (except emergency measures to prevent potential damage to the building or its contents) being made. Include proof of purchase and proof of warranty.
2. Malarkey will be given the opportunity to inspect the roof and be provided with samples before any steps are taken to repair the roof.
3. After verification, the roofing materials or workmanship are defective, Malarkey will perform its obligations under this warranty within forty-five (45) days of receipt of notice, unless performance is delayed by causes beyond Malarkey's control. Any cost in excess of the prorated adjustment if loss is discovered after the Right Start™ Period will be the owner's responsibility.

SOLE AND EXCLUSIVE WARRANTY

THIS LIMITED WARRANTY IS THE ONLY EXPRESS AND/OR IMPLIED WARRANTY MADE BY MALARKEY IN CONNECTION WITH THE SALE OF ITS PRODUCTS. THE TERMS AND CONDITIONS CONTAINED HEREIN CONSTITUTE THE ENTIRETY OF YOUR LIMITED WARRANTY, REGARDLESS OF ANY FUTURE REVISIONS OF WARRANTY TERMS FOR LATER-INSTALLED SHINGLES.

NO REPRESENTATIVE OF MALARKEY OR ANY OTHER PERSON HAS ANY AUTHORITY WHATSOEVER TO ACCEPT FROM OR FOR MALARKEY, ANY ADDITIONAL OR DIFFERENT LIABILITY OR RESPONSIBILITY FOR MALARKEY PRODUCTS. NO SAMPLE WARRANTY AVAILABLE ON MALARKEY'S WEBSITE OR ELSEWHERE WHOSE TERMS AND

CONDITIONS DIFFER FROM THOSE CONTAINED HEREIN WILL BE APPLICABLE TO YOUR SHINGLES.

MALARKEY SHALL NOT BE LIABLE FOR DAMAGE TO ANY BUILDING OR CONTENTS OR INJURY TO PERSONS OR FOR ANY CONSEQUENTIAL DAMAGES RESULTING FROM BREACH OF THE WARRANTY OR ANY OTHER WARRANTY OR CONDITION, IMPLIED BY LAW OR OTHERWISE, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS. SOME STATES AND PROVINCES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES; THIS EXCLUSION MAY NOT BE APPLICABLE IN ALL STATES AND PROVINCES. THIS WARRANTY GIVES SPECIFIC LEGAL RIGHTS; THERE MAY BE OTHER RIGHTS THAT VARY STATE TO STATE AND PROVINCE TO PROVINCE.

THE PARTIES AGREE THAT ANY CLAIM, DISPUTE, OR CONTROVERSY RELATING TO OR ARISING FROM THIS WARRANTY SHALL BE SUBMITTED TO BINDING ARBITRATION UNDER THE RULES OF THE AMERICAN ARBITRATION ASSOCIATION (OR OTHER MUTUALLY ACCEPTABLE ARBITRATOR) THEN IN EFFECT. The expenses of the arbitration shall be allocated among the parties by the arbitrator[s] as part of the award, which shall include the prevailing party's reasonable attorneys' fees and costs, including expert fees. THIS IS A BINDING ARBITRATION PROVISION THAT MAY BE ENFORCED BY THE PARTIES.

This warranty is enforceable only by the original owner named below or the eligible new owner who has filed a timely warranty transfer request and received confirmation from Malarkey the transfer was accepted.

This Emerald Premium Warranty will not be valid until the Emerald Premium Certified Residential Contractor who installed the roof completes the WARRANTY REGISTRATION online at www.malarkeyroofing.com, and the warranty has been accepted by Malarkey Roofing Products.

The owner and eligible new owner should retain all documents and proofs of purchase of Malarkey products for submission to Malarkey should a claim arise.

General Information

Thank you for choosing Malarkey Roofing Products® for your new roof system. A quality roof system protects the investment you have in your building, and we at Malarkey appreciate the responsibility you have given us as your product manufacturer. We take this responsibility seriously and will do all in our power to ensure your roof provides protection season after season.

As the owner of a Malarkey roof system, there are things you can do to ensure the continued performance of your new roof. Care and maintenance of the roof are generally simple, and efforts expended for periodic maintenance will pay dividends in extended roof life and reduced problems over the life cycle of your roof.

Malarkey system warranties are provided on applicable roof systems pre-approved by Malarkey and installed by a Malarkey *Commercial Approved Applicator* in good standing. While Malarkey does not own or operate roofing contractor companies, we do “approve” roofing applicators to apply warrantied systems. Only established contractors who, through their reputation in the industry and community, have proven they apply roofs in a professional manner are eligible to install and repair Malarkey NDL warrantied roof systems. The designation, “Malarkey Commercial Approved Applicator,” identifies a contractor who has met our requirements, uses Malarkey’s latest, published installation instructions, and is eligible to apply for a Malarkey roof warranty, but it does not designate him/her as an agent for Malarkey.

We encourage building owners to read and be familiar with the terms of their roof system warranty. Additional information concerning your roof or specific conditions can be obtained from Malarkey.

Procedure for Reporting Roof Issues

Should your roof develop a leak, it is very important it be reported as soon as possible — the warranty states within thirty (30) days of discovery. If left unrepaired, leaks can lead to increased damage to the roof system, the building, and its contents.

Our hours are 7:00 am to 5:00 pm, Monday through Friday, Pacific Standard Time. Be prepared to provide the owner’s name, address and contact, warranty number, and who to contact for the investigating contractor to gain access to the leak location[s].

Roof Repair

Once a leak is reported, Malarkey will:

- Send an investigation repair request to the original Commercial Approved Applicator [usual practice] or another Malarkey-approved applicator
- Authorize repairs and cover costs under the terms of the warranty
- If not a covered item, we will inform you of our findings and work with you to remedy the problem.

Repairs made at any time during the warranty period must be performed by a Malarkey *Commercial Approved Applicator* to avoid jeopardizing your Malarkey roof warranty. The original contractor will perform repair work in the first two (2) years [or as stated in the contract documents], and Malarkey will cover the balance. If this presents a problem, we will work with you to see if other arrangements can be made. Special circumstances can always occur; contact Malarkey for details or assistance.

Alterations and Modifications

Malarkey recognizes alterations or modifications to a building are sometimes necessary for a variety of reasons. For your Malarkey warranty to remain in force, Malarkey requires changes in building use or anything that could affect, contact, or penetrate the roofing system, be *preapproved in writing* by Malarkey. Unauthorized alterations or modifications can jeopardize or place restrictions on all or part of the Malarkey warranty.



Warranty holders can obtain approval for properly designated alterations and modifications by submitting a written request explaining changes along with detailed drawings of the alterations and their locations on the roof to:

At Malarkey's discretion, inspection of approved alterations to your roof system may be required. Verifications of completed alterations and/or modifications may sometimes be achieved by mailing an explanation of installation procedures and submission of photographs. If circumstances dictate an inspection of your roof system is required, there may be a charge for the inspection service; costs are limited to Malarkey's reasonable out-of-pocket expenditures, including travel.

Inspection Practices

Malarkey recommends you have semi-annual inspections performed by a qualified individual, preferably in the spring and fall. Inspections are also recommended:

- After a severe storm
- Following installation of rooftop appurtenances
- Following maintenance of existing roof-mounted equipment, e.g., HVAC systems
- When the roof is used as an access path by other trades for any purpose

A log of all persons working on the roof or using it for access is recommended. A log should contain name(s), date, a brief description of activities, and their locations on the roof. Such a log may assist in more rapidly determining leak locations and the cause if damage should occur to your roof system.

During an inspection, the condition of all roof components should be reviewed, noted, and photographed. Include the exterior of the building. Settlement or structural movement can cause damage to roof systems.

Conduct an attic inspection to look for signs of leaks and/or *condensation*. Ensure all dryer and bathroom vents are exhausting to the exterior. Check to see that intake and exhaust vents are not blocked. Condensation is usually the result of lack of *ventilation*.

Reports and photos can be forwarded to Malarkey if warranty work is needed, or used by contractors to bid the work. The selection of a contractor for repair work should be done in conjunction with Malarkey. As noted in an earlier section, *Roof Repair*, the selection of contractor can affect your warranty. *Use only Malarkey Commercial Approved Applicators on warrantied roofs.* Obtain pre-authorization for all repairs and/or alterations.

Repairs

Areas in need of repair must be corrected with like procedures and materials. Variations to the original application methods may be needed depending upon job circumstances. These variations must be pre-approved by Malarkey.

The owner or in-house maintenance personnel can handle many maintenance repairs, but Malarkey recommends significant repairs or work requiring a working knowledge of roofing is best left to a *Malarkey Commercial Approved Applicator*.

SPECIFIC AREAS OF INSPECTION

Inside the Building

Start on the interior because the first signs of potential problems may be apparent there first. It's important to understand even the smallest leak can be a sign of trouble. Look for and be aware of:

- Dark spots and water stains in attics, on ceilings, in ceiling corners, or around skylights

BUILT-UP AND MODIFIED ROOF SYSTEMS

Roof System and Base Flashings: Carefully check the entire roof surface, protective coatings, vertical base flashings, and areas of sealant application for signs of deteriorated conditions such as:

- Excessive wear and tear or surfacing loss
- Damage such as cuts, punctures, or breaks
- Wind or storm damage; ponding water
- Visible attacks by spilled chemicals [coolant, acids, oil, grease] or environmental contaminants like bird feces
- Unauthorized and/or improperly installed penetrations



Metal Flashings and Roof Accessories

Gravel Stops/Edge Metal: Inspect these areas for separation between the roof membrane and metal, and evidence of rusting, wind damage, or breaks at lap joints.

Metal Roof Jacks: Inspect pipe and vent locations for cracking or separation of membrane sheets from the metal flanges. Check the condition of the secondary application of sealant around the base and where else applied.

Drains and Scuppers: Inspect all locations and clear the outlets of obstructions. Ensure drain bolts are tight and clamping rings are not cracked. Check for voids, gaps, or separations between the roof membrane and metal flanges.

Metal Counter Flashings: Check for rust, damage due to wind or vandalism, and ensure metal is securely fastened. Check the condition of sealants. Replace any missing or damaged metal beyond repair.

Pitch Pans: Though not covered by the warranty, check for cracks or separation between the roof membrane and metal flanges. Inspect existing condition of pitch pan filler for excessive shrinkage.

Metal Wall Copings, Drip Edge Flashing, and Gutters: Inspect the metal for rust, damage due to wind, vandalism, and the condition of seam covers and sealants. Ensure coping is securely fastened.

Roof-Mounted Equipment: Curb-mounted vents, ducts, skylights, and HVAC units must be inspected for damage from service personnel, wind damage, and leakage of chemicals.

Cleaning the Roof Surface, Gutters, and Downspouts: Roofs should be cleaned on a regular basis, and all trash, debris, and dirt collected and removed. Leaves and tree branches must be kept from hindering drainage of water in valleys and to outlets.

Caulking and Mastics: These are maintenance items and should be inspected and routinely maintained by the building owner.

STEEP SLOPE ROOF SYSTEMS [SHINGLES]

Roof System: Carefully inspect the entire roof surface and all flashings for signs of deteriorated conditions such as:

- Excessive wear and tear or surfacing loss
- Damage such as cuts, punctures, or breaks
- Displaced shingles

- Wind or storm damage
- Visible damage caused by spilled chemicals or environmental contaminants like bird feces
- Unauthorized and/or improperly installed penetrations
- Cracked or worn rubber boots around vent pipes

Shingles: Check shingles for any that may be loose, cracked, or broken. Replace when necessary and/or hand-seal loose tabs with shingle tab adhesive conforming to ASTM D4586.

Chimneys, Sidewalls, and Vertical Transitions – Ensure all:

- Metal step flashing and counter flashing is present and secure
- Shingles are embedded in asphalt roof cement where they contact metal flashing

Counter Flashing, Drip Edge Flashing, Coping, and Gutters: Check condition of metal for rust, damage due to wind, vandalism, and the condition of seam covers and sealants. Ensure coping and gutters are securely fastened. Replace any missing or damaged metal beyond repair. Re-secure and re-seal as necessary.

Roof-Mounted Equipment: Curb-mounted vents, ducts, skylights, and air conditioning units must be inspected for damage from service personnel, wind damage, and leakage of chemicals.

Metal Roof Jacks: Inspect pipe and vent locations for cracking or separation of shingles from the metal flanges. Check the condition of secondary sealant applications around the base and where else applied. Re-seal as needed.

Cleaning the Roof Surface, Gutters, and Downspouts: Roofs should be cleaned on a regular basis, and all trash, debris, and dirt collected and removed. Leaves and tree branches must be kept from hindering drainage of water in valleys and outlets. Accumulation of dry leaves can also present a fire hazard. Cut back tree branches that stretch over the roof; increased sunlight will help dissipate moisture and discourage moss growth.

Re-Inspect the Roof Surface

Cleaning, repairs, and maintenance can result in unintended damage caused by foot traffic, use of chemicals, dropped tools, etc. Best to have one last look.
